



**Independent Auditor's Report on Limited Review of the Unaudited Financial Results of the

We have reviewed the accompanying statement of Unaudited Standalone financial results of **Abhinandan Enterprises Limited** ("the Company") for the quarter ended June 30, 2020 ("the statement"), being submitted by the Company pursuant to the requirement of regulation 33 of the SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015 read with Circular No. CIR/CFD/FAD/62/2016 dated July 5, 2016.
