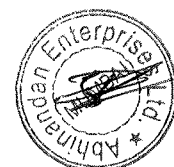



**Report on the audit of the Standalone financial results**

**Opinion**

We have audited the accompanying standalone statement of quarterly and year to date financial results of **ABHINANDAN ENTERPRISES LIMITED** ("the Company") for the quarter ended 31<sup>st</sup> March 2021 and the year to date financial results for the period from 01<sup>st</sup> April 2020 to 31<sup>st</sup> March 2021 (the "Statement"), attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligation and disclosure Requirement) Regulations, 2015, as amended (Listing Regulation).

In our opinion and to the best of our information and according to the explanations given to us, the standalone statements:

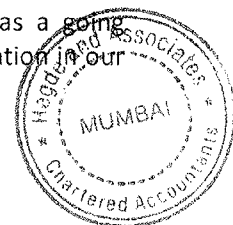
The Board of Directors are also responsible for overseeing the Company's financial reporting process.

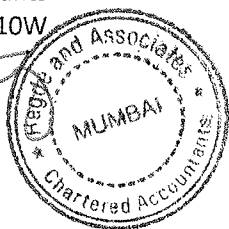
