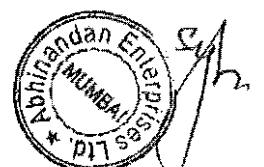

Independent Auditor's Report on Limited Review of the Unaudited Financial Results of the company for the Quarter ended 30th June, 2015.

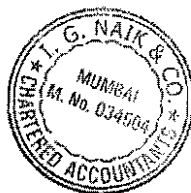
